INDIVIDUAL HOUSE STAFF CONTRACT

- 1. This individual House Staff Contract is subject to the Rules and Regulations of the N.Y. City Health and Hospitals Corporation (the "Corporation") and the provisions, terms and conditions of the agreement which has been reached or which may be negotiated between the City of N.Y., the N.Y. City Health and Hospitals Corporation, and the certified collective bargaining representative of these titles.
- 2. In the event of any inconsistency between this individual House Staff Contract and the collective bargaining agreement, the collective bargaining agreement shall take precedence unless the collective bargaining agreement authorizes such inconsistency.
- 3. I shall remain employed by JACOBI MEDICAL CENTER for the full period of service except for the period of time I am employed by an affiliate hospital in accordance with paragraph four below unless terminated or suspended from service by the Corporation pursuant to applicable disciplinary procedures as contained in the applicable collective bargaining agreement.
- 4. The residency rotation for the period of this contract will be in accordance with the applicable Residency Review Committee program standards, policies and guidelines. In fulfillment of the residency training requirement a House Staff Officer may be required to perform services in another hospital and may be a non-Corporation hospital.
- 5. I shall provide the clinical department and the facility Personnel Department with originals of my medical, dental or osteopathic school diploma: dental permit, if applicable: a letter from the Dean of the school, a valid ECFMG Certificate and appropriate visa, if applicable: and any other information required by the New York City

Health and Hospitals Corporation no later than four weeks prior to the commencement of service. I understand that it is my responsibility to have any written communications translated to English. Further, the translator shall execute a notarized statement swearing that he or she has read the particular document(s) and that his or her written English translation is a true and accurate statement of the same. In exceptional circumstances the Executive Director or designee may waive, in writing, the time requiremen

- t but in no event may a house staff officer be permitted to work without providing the Personnel Department with the original of the medical, dental or osteopathic school diploma: medical of dental license: dental permit, if applicable; a letter from the Dean of the school, a valid ECFMG certificate and appropriate visa, if applicable, and any other documents deemed appropriate by the Corporation. All other documents required by the Corporation shall be provided within 4 weeks after the commencement of service.
- 6. I agree to accept all assignments of duty made by the Executive Director, the Clinical Department Chairman of their designee and shall perform my duties in a professional and satisfactory manner. I understand that MOONLIGHTING is PROHIBITED during the PGY 1 year, but is permitted, thereafter, only if the opinion of the Chief of Service, it does not impinge my performance or educational obligations.
- 7. It is understood that I have the choice of living in the Hospital quarters provided for HSO, if available, or of living out with a cash allowance in lieu of live in, it is further understood that when on duty, I have the use of an on-call sleeping accommodation only when I am assigned on-call duty in the hospital.
- 8. I shall abide by the rules and regulations governing House Staff of the hospital and by any rules and regulations established by the N.Y. City Health and Hospitals Corporation, Executive Director, Medical Board, State or Federal agencies during my residency.
- 9. I agree that I shall complete the medical records of each patient for whom I have had primary medical responsibilities within 3 days of the discharge or death of that patient. I further understand that I have the responsibility to complete any other required medical records in a timely fashion. I understand that failure to comply with this provision may cause for disciplinary action.
- 10. I agree to return all hospital and Corporation property to the hospital as of the last day of this individual contract unless my employment is continued and a new individual agreement is signed prior to the expiration of this contract. Failure to return hospital and Corporation property will result in the deduction of the replacement

cost of the property from my paycheck.

- 11. The provisions of this individual House Staff Agreement are only applicable when I am on the payroll of the New York City Health and Hospitals Corporation.
- 12. I, the undersigned, represent and warrant that I have read and understood the information contained herein and do hereby agree to accept the terms shown above.
- 13. I hereby authorize any the North Bronx Healthcare Network to request and obtain all of my records of my medical school records, personnel records (including recommendations, and other pertinent information with respect to my performance in medical school, as an intern, resident or fellow, and in connection with my prior or current associations with or at all academic or healthcare facilities.

In connection with the release of such information, I hereby waive any rights as to confidentiality and I release all institutions, organizations and individuals who provide, receive, and use such information, in good faith and pursuant to my credentialing and to the request of any or all of the above facilities, from liability or claim for damages in connection with the release of information. Such institutions, organizations, and persons providing, receiving, and using such information shall also be entitled to all the protection set forth in federal, state and local laws and regulations regarding the release and use of that information.

House Officer Agreement, dated as of July 1st, 2009 between Jacobi Medical Center of the New York City Health and Hospitals Corporation ("HHC"), a Public Benefit Corporation organized under the laws of the State of New York Jacobi Medical Center and

A. TERMS OF APPOINTMENT

In consideration of the mutual promises set forth in this agreement, the Medical Center hereby offers and the House Officer hereby accepts a term of appointment of 12 months as a - ear post graduate level in the Department of beginning on, ending on unless earlier terminated as set forth herein.

STIPEND; BENEFITS R

- 1. The House Officer shall receive a stipend at the annual rate of \$64,964 + \$2,900 (meal allowance) totaling \$67864, payable in arrears in biweekly installments by check.
- The House Officer shall be entitled to receive fringe benefits of the types and in the amounts specified by the Committee of 2. Interns and Residents ("CIR") contract with the New York City Health and Hospitals Corporation ("HHC"). C. REQUIREMENTS FOR APPOINTMENT; HOUSE OFFICER REPRESENTATIVES

- As a condition precedent to appointment, the House Officer must meet all of the following requirements prior to the 1. commencement of the term of appointment or this agreement shall be null and void:
- He/She shall graduate fro a medical school offering a medical program accredited by an accrediting organization acceptable a. to the New York State Education Department;
- He/She shall provide the Medical Center with all credentialing information which the Medical Center shall require him/her to provide, including but not limited to, medical school diploma and transcript; b.
- If he/she is not a citizen of the United States, he/she shall obtain a valid visa or other appropriate authorization to work in the C. United States and a House Officer during the terms of this Agreement, which authorization shall be acceptable to the government agencies having jurisdiction there over;
- He/She shall have satisfactorily completed all requirements of the training program in which he/she is enrolled for the d. preceding academic year.
- The House Officer represents that no disciplinary action or investigation or misconduct proceeding has been taken against him/her by any medical training program, hospital, health care institution or medical licensure or disciplinary agency, and that 2. he/she has never been convicted of or entered a plea of guilty or "nolo ontendere" to a felony or any other crime involving moral turpitude, nor has any malpractice action commenced against him/her, except as he/she previously disclosed in writing to the Medical Center, acknowledges that this House Officer Agreement is expressly conditioned upon the truth and accuracy of the foregoing representatives; and agrees promptly to disclose any such actions, investigations, proceedings, convictions or pleas to the Medical Center on an ongoing basis.

D. **HOUSE OFFICE RESPONSIBILITIES**

The House Officer agrees to fulfill obligations and responsibilities:

- To follow all administrative policies, procedures, rules and regulations of the Medical Center as the same may hereafter be 1. modified and/or by the Board of Trustees.
- To perform the duties and obligations of a House Officer to the best of his/her ability, provide clinical services commensurate 2. with his/her level of advancement and responsibilities, carry out assigned patient care and other responsibilities and do everything possible to protect and promote the health and safety of patients at the Medical Center;
- To comply with the instructions and directions of the Administration of the Medical Center, the Chairman of the Department, 3. the members of the Attending Staff of the Medical Center under whose supervision the House Officer may be from time to time, and senior members of the Department.
- Not to bill Medical Center patients or accept payments or gratuities from Medical Center patients for the rendering of 4. professional services.
- To adhere to his/her delineation of privileges and any other guidelines or restrictions imposed on the professional activities of 5. post-graduate medical trainees at the Medical Center, and to endeavor all times to perform only those specific treatments and procedures that he/she has been authorized in writing by Director of Training or Medical Center Department to perform.
- To obey and adhere to all applicable state, federal and local laws, as well as the standards of applicable regulatory, licensing 6. and accreditation bodies, including the Joint Commissions for the Accreditation of Health care Organization ("JCAHO") and the Accreditation Council for Graduate Medical Education ("ACGME");
- To participate fully in the educational and scholarly activities of the Department's graduate Medical education resident training 7. program (hereinafter referred to as the "Program") and satisfactorily fulfill the educational requirements of the Program;
- To maintain cooperative relationships with other House Officers, members of the Attending Staff and Medical Center 8. Employees, and to avoid disruptive behavior which could potentially have adverse impact on patient care;
- To cooperate fully with all Medical Center, departmental, ACGME or Residency Review Committee ("RRC") surveys, reviews, 9. peer review and quality improvement activities and to provide all information requested by such bodies;

- To strictly abide by the ethics of his/her profession, and avoid acts and omissions constituting professional misconduct under state licensing laws and regulations;
- 11. To maintain the confidentiality of patient clinical information;
- 12. To complete all required patient care records in a thorough, professional, accurate and timely fashion, and to complete such other documentation as required by the Medical Center, department, RRC, or ACGME;
- 13. To achieve full and unrestricted licensure in New York State as soon as possible under New York State Law;
- 14. To comply and keep current with all health requirements and standards for hospital employees imposed by New York State Law and by the Medical Center, including submission to a post-offer, pre-appointment physical examination and submission of evidence of required immunizations.

THE HOUSE OFFICER ACKNOWLEDGES THAT FAILURE TO COMPLY WITH ANY OF THE PROVISIONS OF THIS "SECTION D" SHALL CONSTITUTE GROUNDS FOR DISCIPLINARY ACTION.

E. MEDICAL CENTER RESPONSIBILITIES

The Medical Center agrees to fulfill the following obligations and responsibilities;

- 1. To provide a suitable environment for the medical educational experience:
- 2. To provide a training program which meets the standards of the essentials of an approved program of the internship/Residency Council for Medical education of the American Medical Association;
- 3. To provide a stipend and benefits as set forth in the Agreement.

F. TERMS AND CONDITIONS OF APPOINTMENT

- 1. The Administration and/or the Chairman of the Medical Center Department shall have the right, at any time and without advance notice, in their sole discretion, to change the House Officer's assignment without liability of any kind, provided the transfer complies with the essentials of an approved Internship/residency training program of the appropriate specialty Board;
- 2. The hours of duty and direction of the House Officer's assignments shall be determined by the University Chairman, Chairman of the Medical Center Department and his/her designee.

G. PROFESSIONAL ACTIVITIES OUTSIDE OF PROGRAM

The House Officer shall not engage in any employment outside the medical Center, paid or unpaid, in the PGY-1 year. After the PGY-1 year is completed, moonlighting is permitted subject to the terms specified in the CIR Contract, Article VII, Section 5. Notwithstanding receipt of prior written approval, the House Officer warrants that he/she will under no circumstances engages in any outside employment if, by doing so, he/she will thereby (I) violate the restrictions imposed by New York State Law on the working hours of post-graduate medical trainees, or (ii) render himself/herself ineligible to work his/her scheduled hours at the Medical Center.

H. PHYSICIANS IMPAIRMENT AND SUBSTANCE ABUSE POLICY

The House Officer shall abide by the Policy on Physicians Impairment and Substance Abuse, a copy of which is set forth in the CIR Contract, Article XV, and the medical Center Employee Handbook.

I. TERMINATIONS

1. The parties have entered into this agreement in good faith and acknowledge their respective ethical and legal obligations to fulfill this agreement until its expiration date. Neither party shall terminate this agreement prior to its expiration date except for "Cause" for the Medical Center to terminate this agreement, which shall include, but not limited to, a breach of any provision of this agreement by the House Officer.

J. GRIEVANCE: GENDER/SEXUAL HARASSMENT

- 1. Grievances by the House Officer concerning disciplinary actions which may harm his/her professional training shall be resolved in accordance with the Grievance Procedure for the House staff set forth in the CIR Contract, article XIV.
- 2. Complaints of gender or Sexual Harassment shall be resolved in accordance with the Policy Statement on Sexual Harassment set forth in the HHC Policy distributed at the Medical Center orientation.

K. REAPPOINTMENT; PROGRAM CLOSURE OR REDUCTION

- 1. The duration of this Agreement is for a term of 12 months. Reappointment shall be in the sole discretion of the University Chairman of the Department and is contingent upon several factors, including but not limited to: full compliance with the terms of this Agreement, satisfactory completion of all training components, satisfactory performance evaluations, the availability of a position, closure or reduction in the size of the Program and furtherance of the Medical center's objectives.
- 2. When non-reappointment is based on the House Officer's performance or breach of this agreement, it shall be subject to the Grievance Procedure for House Staff.
- 3. The Medical center shall inform House Officers of a program's closure or reduction in the size, as soon as possible after the decision to close or reduce the size of the program is made and shall afford any House Officers who are displaced by such closure or reduction reasonable assistance inidentifying a program in which they can continue their education (also see CIR Contract, Article VI, (Section 5).

L. MISCELLANEOUS

This Agreement contains the whole understanding of the parties and supersedes all prior oral orwritten representation. It may be modified only by written agreement signed by both parties.
